We know you care how information about you is used and shared. This notice describes our privacy policy. What Personal Information Do We Gather?

We receive and store any information you give us in any way. We use the information you provide for such purposes as responding to your requests, customizing services, and communicating with you. This information is stored in our secure Data Base and we have appropriate security measures in place in our physical facilities to protect against the loss, misuse, or alteration of information that we have collected from you.

We require information from you as necessary to compile sufficient data to secure and protect the interest of the contractors, employees, clients, lenders, etc. This information may include Name, Social Security Number, Work and Education History, References, etc. In some instances this data will be used for background checks, reference and work validations, and other security measures necessary in the Mortgage Industry to best protect all entities involved. The information obtained is never sold or distributed in any manner other than specified for the job.

As to Employer/Employee staffing: Information received is added to our database and disseminated as necessary to match clients and employees (contractors, temp to hire and permanent placement) in the mortgage industry.

As to Lender/Broker Contracts: Information received for legal review, quality assurance review, audits, processing, underwriting, closing, or special projects, is kept confidential and never released to third parties.

Agents:

We employ individuals to perform functions on our clients and/or our behalf. Examples include but are not limited to, fulfilling orders, analyzing data, providing mortgage processing, underwriting, closing, post closing, quality control review, legal review, funding, appraisal or documentation review or project management. The information regarding experience, work history, background information, etc., will be shared with prospective clients, and they will only have access to personal information needed to perform the specifics of their job requirements and may not use it for other purposes.
